Chili makers are encouraged to enter their favorite pot of chili for competition. There is no entry fee! Each contestant will be asked to **provide three gallons** of their favorite chili. All who attend the dinner will cast a vote for the chili they consider to be their favorite. Prizes will be awarded to the top three entries receiving the most votes, in three categories of "Mild" and "Hot" and "Unique". Medium will be categorized as "Mild". The grand prize winner over-all will have their name engraved on a Grand Champion Chili-Cook Off plaque! This plaque proudly hangs in the FIA Office with the names of all former winners. The grand champion will also receive a trophy to commemorate their accomplishment. This year a name does not have to be chosen for the chili. Each entry will receive a number the evening of the event. They will just be put into their own category of hot, mild or unique. We encourage individuals, congregations, agencies, organizations, clubs and businesses to enter their favorite pot of chili and join the fun!

This is a great evening with light hearted friendly competition. It is also one of the two major fundraisers hosted by Faith in Action for the year. Advanced sale tickets are available now. - 1. To date we have had 171 volunteers to enlist as FIA Volunteers, with 93 currently active.
- 2. We have been able to reach out to 677 residents and their families, with 253 currently active.
- 3. Our Special Project volunteers have completed **293** wheelchair ramps for residents throughout the county. There is always a waiting list for Ramps, Step, Handrails and inside safety devices such as grab bars.
- 4. Since September 2003 Volunteers have driven over **290,000 miles** and shared more than **30,200 hours** of service by reaching out to neighbors who need a little help remaining independent.
- 5. Youth groups get involved, learning the joys of working together to help others with Spring and Fall Cleaning.
- 6. Services provided include Transportation, in-home Visiting, Telephoning, Sewing and Mending, Shopping and Errands, Yard Work, Laundry, Card Creating, Special Projects such as wheelchair ramp construction and minor home repair, and Clerical and Fundraising Assistance.
- 7. Services are provided at <u>no charge</u> to the Care Receiver.
- 8. Faith in Action is a Nonprofit, Interfaith, Volunteer, Caregiving program. All services are Non-medical.
- 9. We operate solely on <u>donations</u>, <u>grants</u> and <u>fundraisers</u>, <u>individual donations</u> and <u>congregation mission</u> giving, and the Edgar County United Way.
- 10. Faith in Action of Edgar County receives no government funding.
- 11. **31 congregations and 12 agencies partner with Faith in Action of Edgar County** to help residents with various needs.
- 12. Volunteers gain personal satisfaction knowing they are a valuable asset to their community, by utilizing skills that help others remain living in their own homes for as long as safely possible.

Influenza ~ Tis' the Season



Influenza, commonly called the flu, is caused by viruses that infect the respiratory tract (nose, throat and lungs) and spread from person to person when an infected person coughs or sneezes. Unlike many other viral respiratory infections, such as the common cold, the flu can cause severe illness and life-threatening complications in some people. The best way to prevent this illness is by getting a flu vaccination each fall. The flu season usually runs from November until April and often peaks between January and March. While October and November is the best time to be vaccinated, a flu shot can be given any time during the flu season.

Symptoms of flu include fever, headache, extreme tiredness, dry cough, sore throat, runny or stuffy nose, and muscle aches. Children can have additional gastrointestinal symptoms, such as nausea, vomiting and diarrhea, but these symptoms are uncommon in adults. Although the term "stomach flu" is sometimes used to describe vomiting, nausea or diarrhea, these illnesses are caused by other viruses, bacteria, or possibly parasites, and are rarely related to influenza. Influenza is highly contagious. After a person has been infected with the virus, symptoms usually appear within one to four days, with an average of about two days. Once infected, a person may be contagious from one day prior to becoming sick to five days after they first develop symptoms. Some young children and people with weakened immune systems may be contagious for longer than a week.

Typical treatment includes getting bed rest, drinking plenty of liquids, avoiding alcohol and tobacco, and taking medication to relieve the symptoms of flu. In some cases, certain antiviral drugs may be prescribed to treat the flu. Influenza is caused by a virus, so antibiotics, such as penicillin, do not cure it. Never give aspirin to children or teenagers who have flu-like symptoms, particularly fever, without first speaking to your doctor.
